- Lwfans Cyflogaeth a Chymorth yn Seiliedig ar Incwm
- Credyd Treth Plant ac nid yw eich incwm blynyddol yn fwy na £16,190
- Ategiad Credyd Treth Gwaith – wedi'i dalu 4 wythnos ar ôl i chi beidio â bod yn gymwys am Gredyd Treth Gwaith
- Credyd Cynhwysol ac nid yw incwm net blynyddol eich aelwyd yn fwy na £7,400 (£616.67 y mis)
- Cymorth o dan ran VI o Ddeddf Mewnfudo a Lloches 1999

Os ydych yn derbyn Credyd Treth Gwaith yn ogystal ag unrhyw un o'r budd-daliadau hyn, ni fyddwch yn gymwys, hyd yn oed os yw incwm yr aelwyd yn is na £16,190.

Os ydych eisoes yn derbyn prydau ysgol am ddim ac angen rhoi gwybod i ni am newid yn eich amgylchiadau e.e., newid cyfeiriad, ysgol, newid hawl i fudd-daliadau neu blentyn ychwanegol yn mynychu'r ysgol, mae angen i chi roi gwybod i ni am eich 'Newid mewn Amgylchiadau'.

Os ydych eisoes yn derbyn prydau ysgol am ddim ond nad oes unrhyw newid yn eich amgylchiadau, NID oes angen i chi wneud cais eto.

Financial Support

Free School Meals

You could be eligible for free school meals if you receive one of the following benefits:

- Income Support
- Income-based Job Seeker's Allowance
- Guarantee element of State Pension Credit
- Income-related Employment and Support Allowance
- Child Tax Credit and your annual income is no more than £16,190
- Working Tax Credit run-on-paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit and your household's annual net income is no more than £7,400 (£616.67 monthly)
- Support under part V1 of the Immigration and Asylum Act 1999

If you are in receipt of Working Tax Credit in addition to any of these benefits you will not be eligible, even if the household income is below £16,190.

If you are already in receipt of FSM and need to inform us of a change in your circumstances e.g., change of address, school, change of benefit entitlement or an additional child attending school, you need to inform us of your 'Change in Circumstances'.

If you are already in receipt of Free School Meals but have no change of circumstances, you do NOT need to apply again.
